DEED OF GIFT

I, the undersigned Donor, hereby donate and convey to the University of Washington Libraries the following materials:

Name of Collection: Bob and Ira Spring Photographs

Description of Collection: Collection of Photographs

I hereby transfer, convey and assign any literary rights, copyrights, or other rights that I possess to the contents of the above named materials (including future additions I may make to them) to the University of Washington Libraries within the limits stated below.


The UW Libraries may allow reproduction of these materials within the limits stated below.

These materials and any future additions I may make to them shall be accessible to all persons, including undergraduates and the general public, from the date of this gift subject to the terms and conditions stated below.

The University of Washington Libraries may use its discretion in disposing of materials considered inappropriate for archival retention. Unless other arrangements are made, the Libraries will reassign or dispose of unwanted materials contained in a collection.

Additional terms and conditions:

1. John and Vicky Spring shall retain copyright to the collection for 10 years from the date of the gift. After that time, the copyright shall transfer to the University of Washington.
2. Until the copyright date expires, requests to acquire reproductions of materials in the collection must be approved by John or Vicky Spring or their designated representative.
3. Until the copyright expires, requests to use materials in the collection must be approved by John or Vicky Spring or their designated representative.
4. Approvals from John or Vicky Spring or their designated representative for reproductions or usage must be sent to the Special Collections representative in writing.
5. Unless otherwise indicated by John and Vicky Spring, the designated representative for them will be Lowell Skoog. All requests will first be sent to John and Vicky Spring. If they are not available, then requests will be sent to Lowell Skoog. Mr. Skoog will have the same authority to grant permission to reproduce or to use Ira Spring images.
6. John and Vicky Spring and Lowell Skoog agree to provide Special Collections with their current contact information until the copyright transfers to the University of Washington.
7. UW Libraries grants non-exclusive, royalty-free use of the photographs in the Bob and Ira Spring Photographs to The Mountaineers by written request from The Mountaineers Executive Committee or the Chairman of the History Committee or designee.



8. The Mountaineers Executive Committee or History Committee or their designated representatives shall be able to obtain reproductions at their own expense (or may be allowed to make their own copies from the collection on-site in Special Collections). This will not be subject to approval from John and Vicky Spring.

9. The University of Washington shall have permission to digitize photographs from the collection and publish copies on the UW Libraries digital site or other Libraries websites. All digitized photos shall include a credit indicating that they belong to the Bob and Ira Spring collection.
